Radha is an 11-yearold girl child. She lives with her parents and grandparents.

Her parents are farmers, who also run a small grocery shop in the village.

During her free time, Radha helps her mother with her household chores.

During holidays when her father goes to the market to buy goods for the shop, Radha looks after the customers who visit the shop.



#### Bire

Bire is 12 years old. He travels with his family to work at brick kilns.

Bire's family owes money to brick kiln owners. In order to pay off this loan, the entire family works on the kilns for several months in a year. Bire works long days. Most frequently he is found working from early morning to late evening.



Bire's primary work is to carry the bricks from one place to another. There are times when he is required to carry bricks weighing approximately 40 kgs.



Due to his work hours, Bire neither goes to school, nor has time to play with boys of his own age. He does not have many friends.

At night Bire is so tired, he sleeps as soon as his head touches the pillow. And then he wakes up early to start another busy day.

(After checking all the birth certificates) I am glad you brought along the birth certificates. As you know, my kiln strictly prohibits the hiring of children below age 14. Young workers between the ages of 14-16 are hired, but some conditions are strictly followed: They are not

- Work in any hazardous operations like firing, coal crushing etc.;
- Work on machines considered dangerous;
- Work more than 6 hours per day or between 6 pm to 6 am
- Carry load above 15 Kgs
- Do overtime hours

And they are provided one weekly rest day after six days of work!

Young workers between 14 to 16 years are not yet fully grown, either physically or emotionally. They therefore cannot be expected to work at the same pace, level or intensity as an adult worker.

While they can be allowed to work, we need to ensure that they are given the type and quantum of work that is appropriate for their age .
